CAPTAIN PIPES LIMITED ("the Company") vide, resolution passed by its Board of Directors at their meeting held on Wednesday, March 15, 2023, appointed Mr. Kishor Dudhatra (Membership No. FCS 7236 and COP No. 3959), Practicing Company Secretary, Ahmedabad as the Scrutinizer to ensure that the process of Postal Ballot is conducted in the manner prescribed under Section 108 and Section 110 of the Companies Act, 2013 ("the Act) read with Rule 20 and Rule 22 of Companies (Management and Administration) Rules, 2014 (as amended).

As required under Section 110 of the Act read with Rule 22 of the Rules of Chapter VII, read with MCA General Circular No. 14/2020 dated April 8, 2020, Circular No. 17/2020 dated April 13, 2020, Circular No. 22/2020 dated June 15, 2020, Circular No. 33/2020 dated September 28, 2020, Circular No. 39/2020 dated December 31, 2020, Circular No. 10/2021 dated June 23, 2021, Circular No. 20/2021 dated December 8, 2021, Circular No. 03/2022 dated 5th May, 2022 and Circular No. 10/2022 dated December 28, 2022 issued by the Ministry of Corporate Affairs (MCA") ('herein collectively referred to as MCA Circulars"), the Company has sent the Postal Ballot Notice dated March 15, 2023 and Explanatory Statement under Section 102 of the Companies Act, 2013 by email only to members who have registered their e-mail address with the Company/Depositories.

As per the MCA Circulars, physical copies of the Notice, postal ballot forms and pre-paid business Reply Envelopes were not dispatched to the members for this Postal Ballot. Accordingly, the communication for the assent or dissent of the Members took place through remote e-voting system only.

The Company has published an advertisement on March 17, 2023 in Financial Express, an English Newspaper and in Financial Express, Gujarati newspaper regarding completion of dispatch of Notice of Postal Ballot on Thursday, March 16, 2023 and also specifying therein the matters prescribed in the rules with regard to evoting.

The Company has appointed NSDL for facilitating e-Voting to enable the members to cast their votes electronically (herein referred to as "Remote e-Voting"). Members whose names appeared on the Register of Members/ List of Beneficial Owners as on the close of business hours on Friday, 17th March, 2023 ("Cut-off date") were considered for the purpose of Remote e- Voting. The Remote e-Voting period commenced on Tuesday, 21st March, 2023 (9.00 a.m.) IST and ended on Wednesday, 19th April, 2023 (5.00 p.m.) IST.

Thereafter, the votes cast by the members under the Remote e-Voting facility were unblocked and downloaded from the e-voting website <a href="https://www.evoting.nsdl.com/">https://www.evoting.nsdl.com/</a> in the presence of two witnesses who were not in employment of the Company.

The votes received electronically from members till Wednesday, 19<sup>th</sup> April, 2023 (5.00 p.m.) IST being the last output, date and time fixed by the Company for postal ballot were considered for my scrutiny.
